# Flora City Council Approves Several Agreements At Dec. 21 Meeting By Mary Anne Maxwell Meeting

The Flora City Council met the afternoon of Dec. 21 to consider several agenda items.

Council approval was given to a resolution approving an agreement with JW Heating and Air for replacement of heating and air conditioning units at City Hall and Public Works. A grant will help offset the cost

An ordinance was approved with Justin Cook Management, LLC for lighting at Library Park for five years. Mayor Mike Stanford said Cook promises next year's light display will be "bigger and better". Approval was given for bucket truck repairs in the estimated amount of \$13,320.29 to Drake-Scruggs.

An ordinance was also approved for an extension of a lease agreement with Bill's Machine and Power reau Dec. 31 & Jan. 1, Village Transmission, Inc. The council approved a resolution regarding the Intermediary Relending Program and Community De-

velopment Assistance Program. They approved an IRP (Intermediary Relending Program) loan to Common Grounds Coffee, LLC Dev-

on and Destiny Dannells for a coffee shop in the former Hair Garage Building. Approval was given to retain C.J. Schlosser and Company LLC as auditor. City Attorney Bob Coble

noted Schlosser and Company is the auditor for several cities in the Metro East and this move should also save the City some money.

The petitions have been filed and there will be two ladies running for one open Flora City Commissioner Seat. The open seat is the Commissioner of Public Health and Safety, and is currently occupied by Linda

Spicer was appointed to that seat after Barb Tackitt resigned from the Council as she moved out of state.

Filing for the open seat were Linda Spicer and Donna Mason. The individual who is elected will serve a two-year term, from May of 2021 to April of 2023.

The Consolidated Election will be held on April 6th, 2021.

An ordinance for the Levy and Assessment Taxes for the current fiscal year beginning May 1, 2021 and ending June 30, 2022 was also approved. An ordinance levying taxes for corporate purposes for the same time period was also approved.

The Consent Agenda consisted of routine housekeeping items. Mayor Stanford thanked City Treasurer Jeremy Henderson for his work with businesses to obtain utility grants. He also thanked Commissioner Linda Spicer for helping with this project.

The Police Report for November submitted by Chief of Police Guye Durre contained the following statistics: nine accidents'; 11 criminal arrests; one drug arrest; five local ordinance arrest; 24 traffic arrests; 10 warrant arrests; five warning tickets; 13 alarms; 1,297 calls for service; two juvenile contacts; 1,466 miles driven; 68 investigations; 330 911 calls; and 71 verbal warnings.

The Building and Zoning Report for November showed there were eight residential permits and two commercial permits issued during the month for a total of 10 permits. The value totaled \$980, 298.58. Fees collected totaled \$1,375.

# **Mandated Minimum Wage Increase Continues To Fuel Unfriendly Business Climate & Puts Pressure** On Struggling Economy

State Rep. Darren Bailey (R-Xenia) is informing constituents of the newest laws to take effect at the beginning of the New Year and remind- ID-19 from Dec. 24-Dec. 27. Case demographics for new cases are: ing everyone of the continuing mandated Illinois minimum wage law increases another dollar an hour starting January 1, 2021.

One of the new laws (HB 2708) amends the Missing Persons Iden**tification Act** to require law enforcement to report relevant information and DNA data about missing person's cases to the National Missing and Unidentified Persons (NamUs) System. Another (HB 2818) expands the 'Address Confidentiality for Victims of Domestic Violence Act' to include sexual assault and stalking as reasons a victim may also apply for the address confidentiality program. The third new law (SB 667) limits the cost of insulin 30-day supply to just \$100 whether or not that is the actual cost of providing this medicine.

"Generally there are hundreds of new laws that take effect every January in Illinois. One silver lining of a shortened legislative session this year seems to be fewer laws being imposed on Illinois residents," commented Rep. Bailey. "There are a couple that are intended to help missing persons and victims of domestic violence which I supported When you artificially keep the cost of anything low, the actual cost of the ingredients, processing, and delivery of the product is charged somewhere else in the process, like in the rates of your insurance premiums."

In addition to the three new laws taking effect January 1, there is a previous law that continues to ramp up the minimum wage in Illinois to \$11 an hour. The rate will continue to increase an additional \$1 an gestion or runny nose, Nausea or vomiting, or Diarrhea hour each January 1 until it reaches \$15 an hour in 2025. Workers who are under 18 years old and work fewer than 650 hours in a year will earn a minimum wage of \$8.50 per hour beginning January 1. The youth minimum wage rate will gradually rise to \$13 an hour by 2025.

**Illinois** Minimum Wage **Increases** 

Jan. 1

Minimum wage workers in Illinois will be getting a raise on Jan. 1.


The current state minimum wage is \$10 an hour. That will be increasing to \$11 an hour in the New Year according to the Illinois Department of Labor.

The minimum wage for teenagers working less than 650 hours a year rises to \$8.50 an hour on the 1st, and the minimum wage for teenagers eventually goes up to \$13 an hour.

## **Illinois Secretary Of State Awards Grants** To Library, Unit No. 35

Illinois Secretary of State and State Librarian Jesse White has awarded over \$750,000 in grants to 187 libraries across the state.

Grants ranged from \$465 to \$4,900. The Flora school district received the maximum \$4,900 award, as did the Flora Public Library.
