

Winds Result In Damages A line of strong thunderstorms hit the Clay County area Thursday

morning.

The National Weather Service, in Lincoln, issued a Severe Thunderstorm Warning for all of Clay County just after 10:30 a.m. The storms hit just before 11 a.m.

Area law enforcement and Clay County ESDA reported a wide variety of damage throughout the county. The damage primarily stems from downed trees and tree limbs. Some of those struck homes and vehicles, causing severe damage. There were also reports of numerous power lines down.

Most of the county was also without power for several hours. In the Flora area, the power was out from just after 11 a.m. yesterday morning and started returning in some portions of Flora at approximately

The power outage was attributed to an Ameren issue, which stemmed from storm damage.

"We don't usually have to get any new poles because we always tell the kids when we give them a pole that they can keep 'em," Mr. Lane related. "We get most of the fishing poles back when the Derby's over."

The Lanes began participating in the Kids' Fishing Derby when original organizer Barb Tackitt told them they needed cane fishing poles because the ones they ordered weren't going to come in on time. So they went out to the country and find a cane brake. They cut 70 poles.

"We fixed them with lines and hooks," Mr. Lane said.

In the mean-time, the ordered fishing poles did arrive before the Fishing Derby.

"We never got to use those poles," Mr. Lane quipped. "They're sitting in our barn up at the farm."

Husband and wife themselves like to fish. Every year they go to Montauk State Park in Missouri for a family camping and fishing trip with approximately 40 members of their families.

"Evelyn was born and raised there," Mr. Lane noted. "We've done this for 15-20 years. Our whole family meets us there.'

The Lanes say they have participated in the Kids' Fishing Derby is because of the kids.

"We enjoy seeing the kids fish and seeing the smiles on their faces," Mr. Lane stated.

The Longest Fish Award is given each year of the Kids' Fishing Derby in the Lanes' honor.

"We hate to give it up," Mr. Lane stated. "But I just can't see any more.'

Each year they take the poles home, straighten or untangle the lines if they can, and put on new lines if they need to. They also add new fishing hooks.

Mr. Lane said he never has to buy bobbers because he has a whole sack of those he can use if needed. He also said Briscoes' Surplus has new fishing poles on hand to replace the ones not returned.
